


I am writing to you in regard to Form 925, Candidate's Campaign Deficit Status, which was sent to me from your office on 31st December 2003. I am sending you an itemized list of all the payments that were made in 2003 as described to me by my official agent, Mr. John Rudyk. Also attached is a list of contributors who made donations after the election was over. The donations were passed on to NDP Provincial Office and we were subsequently rebated 70% back to our constituency association.

Payments made toward the debt were as follows:

- 1) On June 16th a cheque from Provincial Office for \$772.10 was deposited.
- 2) On June 19th \$6444.31 was deposited. This was the gross revenue for our annual dinner and fundraiser. Since it was held during the election period, we deposited the money in the election account.
- 3) On July 10th a cheque for \$84.59 was deposited. Mr. Rudyk will know the full details of this entry (he informed me it was related to the fundraising event and simply came in after the fact).
- 4) On July 17th a transfer from our Interlake NDP Constituency Association was made in the form of a cheque for \$1870.00 into the election account.
- 5) On September 18th a cheque from Elections Manitoba for \$4875.99 was deposited into the election account.
- 6) On November 6th a second cheque from Elections Manitoba for \$4875.99 was deposited into the election account.
- 7) On December 3rd a cheque from NDP Provincial Office for \$3836.00 was deposited into the election account. A number of substantial donations were made after the election and they were duly passed on to Provincial Office who subsequently returned 70% of the amount to us to address our debt. (See the attached documentation).
