
AUDITORS' REPORT

To Alex Broughton Official Agent for Andrew Basham,

We have audited Form 947, Leadership Contestant's Financial Statements and Supporting Schedules, and Form 948, Leadership Contestant's Detailed Contributors List, prepared in accordance with the accounting requirements of The Elections Finances Act of Manitoba (the "Act") and Accounting Guide – Accounting for Purposes of The Elections Finances Act issued by the Chief Electoral Officer, for the leadership contestant Andrew Basham for the leadership contest period from August 1, 2006 to January 19, 2006 relating to the leadership contest held on November 19, 2006. The financial statements are the responsibility of the Official Agent and the Leadership Contestant. Our responsibility is to express an opinion on the financial statements based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by the Official Agent and Leadership Contestant, as well as evaluating the overall financial statement presentation.

The Act does not require us to report, nor was it practicable for us to determine, that the accounting records include all transactions relating to the leadership contest of Andrew Basham. Due to the inherent nature of the transactions of leadership contests, the completeness of contributions and other revenue and expenses is not susceptible to satisfactory audit verification. Accordingly our verification of this financial information was limited to the transactions recorded in the contestant's leadership contest records and we did not attempt to determine whether any adjustments might be necessary to any of the financial information disclosed.

In our opinion, except for the adjustments, if any, which might have been determined to be necessary had we attempted to satisfy ourselves on the completeness of transactions referred to in the preceding paragraph, Form 947, Leadership Contestant's Financial Statements and Supporting Schedules, and Form 948, Leadership Contestant's Detailed Contributors List, for Andrew Basham, are presented fairly, in all material respects, in accordance with the accounting requirements of the Elections Finances Act of Manitoba and Accounting Guide – Accounting for Purposes of The Elections Finances Act issued by the Chief Electoral Officer.
